## PELSO CAMPING'S POLICY AT HARLEY-DAVIDSON OPENROADFEST

In 2020, the festival area and the campsite area will be physically segregated, at the request of the campsite, on the basis of another working model similar to the major festivals held at the campsite.

Entry to the festival is done with a valid festival bracelet, the rules and regulations are set by the organizer (H-Budapest Ltd.) and published on its website. Entry to the campsite is subject to a valid accommodation reservation and a valid festival ticket.

The main reason for the separation is that the festival, which is renewed in other elements, is not the same, some of the visitors are locals, others are domestic and foreign tourists, and others are campers. The safety of the festival, the comfort of the campers, and the accident-free transport within the campsite area are limited if the number of participants at the same time is limited in accordance with the capacity of the campsite.

The campsite has a general policy, FAQ, Privacy Policy, available at www.pelsocamping.hu/docs in Hungarian, English and German. The General Terms and Conditions of the campsite shall be amended in accordance with the following points in the event of a festival, and in case of conflict, the following shall prevail.

## THIS POLICY IS VALID FOR THE FESTIVAL WEEK, 06-14.06.2020

- Mobile homes and camp ticket can be booked at least for 4 full days of the festival. The parcel according to the General Policies cannot be booked. Customers of tent entrants will set up the tents at the designated location in the order of arrival. As in previous years, we recommend that you arrive with 1-2 days earlier, for those visitors who want to camp idon their favorite spot. Upon arrival by caravan / motorhome, tent camping admission is required, and the caravan is to be paid extra (1x). The campsite accommodation tickets do not entitle you to visit the festival area. Camping on the beach and in the mobile home area is prohibited.
- Reservations can be made at www.pelsocamping.com/reservation, or by contacting info@pelsocamping.hu. Once confirmed, the reservation will become "Guaranteed" if the accommodation fee has been paid.. No specific house number, only product type can be confirmed, but requests are recorded as a preference if possible. Until January 15, 2020, regular customers who request it may book a specific house with the festival organizer, which is included in our confirmation. After 15/01/2020 we only guarantee the type.
- Check-in is subject to the General Policies. When booking a mobile home, a deposit of EUR 200 will be required, preferably in cash, which will be refunded on departure.
- Entry to the campsite is only with valid campsite accommodation and festival ticket, which will be checked at the main campsite entrance.
- Entry from the festival to the campsite during the valid campsite accommodation will be checked.

  Within the campsite, cash and credit card payments are possible at the service points.
- The campsite reception is open from 8am to 10pm, with technical maintenance from 6am to 2pm.

- Parking is free within the 1km radius provided by the organizer. When booking a mobile home, 1 car parking is included in the price.
- Transport within the campsite at the speed limit in accordance with the General Policies and according to the Highway Code. Driving and parking of the engine on the beach area is forbidden, and if the warning is ignored, the Guest will be banned immediately.
- Between 24:00 and 06:00 no public transport is allowed at the campsite, except for the access to the accommodation. Loudspeakers, drunk drivers, rushers can be warned immediately if they want to rest and avoid harm, and if they do not, they will be banned immediately.
- Guests arriving from 11 am to 12 pm on the opening day of the festival between 10 am and 12 pm on 10 June 2020 will be required to re-enter the festival.
- Prices do not include official tourist tax, final cleaning this will be automatically charged at the time of payment.

Price include bed linen for 4 ppl and air condition.

## OTHER RULES ADOPTED FROM THE FESTIVAL POLICIES, WHICH ARE AN INTEGRAL PART OF THE CAMPING POLICY

- Purchasing a ticket entitles you to enter if you accept the event's policies, terms and conditions, and security rules, and acknowledge that compliance is monitored by the organizers.
- Pre-purchased tickets will be exchanged for armband upon entry. The wristband (leased or daily) must be worn on the wrist for the duration of its validity. This will be continuously monitored by the organizers upon departure and upon entry and within the Event Area. The organizer assumes no responsibility for false tickets being sold!
- The campsite will be entitled to one day of camping stay until 9am the next day. Weekly ticket for camping accommodation on the first day of the event, from 12:00 noon, will entitle you to enter the campsite until its closure (Sunday 23:00). If the ticket / wristband expires but you are happy to stay, the visitor can buy another wristband at the reception. If the wristband is invalid, you must leave the campsite!
- The ticket / wristband is not transferable, you cannot buy back your purchased ticket! Only a handworn wristband is considered a valid entry! DAMAGED cut, larger than hand diameter, etc. ARMBALL INVALID! Anti-counterfeiters and counterfeiters are being prosecuted. Damaged, lost wristbands will not be replaced or replaced.
  - Children under the age of 14 are allowed to accompany the event only with an adult!
- The instructions given by any member of the organizing team must be followed in all circumstances. In the event of non-compliance with the instructions, the Organizer and the Company performing the entrusted security activities may request the Visitor to leave the Festival without any refund or other claim.
  - Please take care of natural values and do not litter!
    - Items that cannot be brought into the event area:

Devices which are particularly dangerous to public security,

- A 175/2003. (X.28.) Government Regulation regulates the range of devices that are particularly dangerous to public security. In view of this, it may not be brought into events (taken away, entailed by a procedure), in particular a stabbing or cutting device having a stab length or cutting edge greater than 8 cm, throwing star, spring knife, stabbing or cutting device or bodily injury other objects (bow, crossbow, french knife, harpoon, sling, slingshot),
- A tool typically used for punching and increasing the impact and impact of the punch (eg lead stick, boxer),
- Sticks, weights, chemicals, gases, sprays (eg gas spray, pepper spray) connected to a chain or other flexible material,
- A device that is similar to a firearm (imitation firearm) in a deceptive manner due to the nature and scale of its imitation, a device capable of causing a state of electrical inactivity (shock) to open or break a locking device.
- o 2. Prohibited devices, objects, in particular compressed air or carbon weapons, gas weapons, signal pistols, starting pistols, pointed or sharp-edged objects (eg ice cutters, ax, white, sniccer), hand tools

(eg crowbar, drills, chisels, screwdrivers, hammers), blunting tools (such as baseball bats), explosives, pyrotechnics, drugs, or other psychoactive substances that are prescribed by law.

- o 3. Other instruments, articles, in particular alcoholic beverages (commercial quantities), tobacco (commercial quantities), gas cylinders, gas burners, gas heaters, glass, umbrellas, rigid rods (more than 1 m), tubes (eg flagpoles), flammable substances and ignition device, pets without leash, muzzle and vaccination certificate. Upon entry, clothing and baggage screening and random drug screening will be performed by the security service. All disputes shall be settled by the local head of the security service. o Prohibited activities at the event, especially bathing, fire, crow surfing, wall of death and any individual or group activity that interferes with or endangers the entertainment or physical integrity of others, camping in a forbidden or confined area, graffiti, or other malpractice, attending an event under the influence of alcohol or drugs and other intoxicants, smoking or using open flames in enclosed venues and tents, unauthorized access to motorcycles and motor vehicles, conduct in the event area that endangers the physical integrity of others. The above activities will result in administrative and indemnification proceedings as well as disqualification from the event area.
- o The rules of the Highway Code must also be observed in the area of the event! Do not drive a vehicle while intoxicated! It is forbidden to smoke in a closed community area (tent, dining room, etc.) according to the law!
- o The organizers are not liable for any damage to persons or property if they result from the irresponsible behavior of the participants.
- o By accepting the Ticket, you agree that if you are taking a photo of yourself, you may not make any claim to the Director, the Recorder or its legitimate User.
- o Visitors entering the Festival also accept, as a suggestion, that the Organizer will take group, photo, group or scan videos in the Festival area and use them on its online (website, facebook, instagram, youtube, google +) interface.
- o The visitor further accepts that the area is under camera surveillance.
