- The advance amount is 50% in case of mobile homes, 100% in case of pitches. 10 days before the day of arrival, guests will receive a reminder e-mail about the payment of the unpaid amount. By transferring the remaining amount on time, You could avoid the traffic at reception, and could directly go to your accommodation.
- Before the arrival, You could fill the check-in form on line.
- **Arrival**, check-in: from 8:00 to 13:00 and from 15:00 to 21:00 hrs, **Departure**, check-out: from 7:00 to 13:00 and from 15:00 to 20:00 hrs, **Pre-ordered accommodations may be occupied from 15:00 hrs.**, **Leaving the pitch** on the departure date: from 7:00 to 12:00 hrs., **Leaving the accommodations** on the departure date: from 7:00 to 9:00 hrs.
- Smoking in mobile homes is not allowed.
- The Camp's entrance gate for cars is open on all opening days in the following periods: 8:00 - 13:00 and 15:00 - 23:00 hrs.
- In case of mobile homes, 200 EUR deposit need to be given in a form of cash or bank card deposit.
- Guest are requested to leave the accommodation tidy. In case of failure, a cleaning fee of 30 EUR will be deducted from the deposit
- Pets are allowed only for pitch guests staying in S2 zone only.
- The accommodations are equipped with pots, tableware, blankets and pillows. Guests must bring their own bed-linen, pillow case and towels, or – subject to special request – they may also rent those from the Service Provider.
